Immigration:

Data from the U.S. Census Bureau for 2010-2014 indicate that 87,672 people or 12.19% of the population living in this area were "foreign born". Census defines foreign born as anyone who is not a U.S. citizen at birth. This area is located in New York, which, according to the Department of Homeland Security, was home to 141,406 people who were granted Legal Permanent Residence status in 2014. Those LPRs, or "green cards", represent 13.91% of green cards issued in the nation that year.

Tenure:

Vacancy:
