### **Racial Characteristics:**

Of the people living in this area in between 2011-2015, 84.14% are White, 7.09% are African American, 9.98% are Hispanic, 2.73% are Asian, 0.03% are either Native Hawaiian or Pacific Islander, 0.29% are American Indian or Alaskan Native, 2.72% are of "some other race" and 3.01% are of two or more races. In the table below, the percentage of the population that each segment represents in the report area is compared to the percent it represents in the state.

Between 2000 and 2011-2015, the White population changed by -0.84%, the African American population by 16.24%, and Asian population by 73.51%. The number of Hispanics changed by 80.88%.

## Incomes:

The median household income for the study area ranged from \$50,278 to \$96,148, compared to the state of New York with a median of \$59,269, as estimated for 2011-2015 by the Census' American Community Survey.

#### Immigration:

Data from the U.S. Census Bureau for 2011-2015 indicate that 67,339 people or 9.78% of the population living in this area were "foreign born". This area is located in New York, which, according to the Department of Homeland Security, was home to 141,406 people who were granted Legal Permanent Residence status in 2014. Those LPRs, or "green cards", represent 13.91% of green cards issued in the nation that year.

### **Tenure:**

Across the area, an estimated 71.48% or 180,983 households owned their home between 2011-2015.
