#### **Immigration:**

Data from the U.S. Census Bureau for 2011-2015 indicate that 46,753 people or 8.34% of the population living in this area were "foreign born". ### Tenure:

Across the area, an estimated 62.62% or 136,117 households owned their home between 2011-2015.
