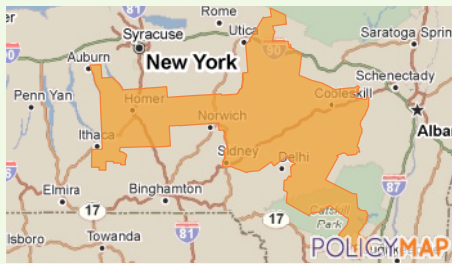

The median household income for the study area ranged from \$43,720 to \$52,624, compared to the state of New York with a median of \$59,269, as estimated for 2011-2015 by the Census' American Community Survey.

Immigration:

Data from the U.S. Census Bureau for 2011-2015 indicate that 18,999 people or 6.48% of the population living in this area were "foreign born". Census defines foreign born as anyone who is not a U.S. citizen at birth. This area is located in New York, which, according to the Department of Homeland Security, was home to 141,406 people who were granted Legal Permanent Residence status in 2014. Those LPRs, or "green cards", represent 13.91% of green cards issued in the nation that year.

Families and Households:

Across the area, an estimated 66.25% or 74,008 households owned their home between 2011-2015. The average size of a household in this area ranged from 2.31 to 2.54 between 2011-2015, as compared to the average household size for the county and the state, 2.4 (Herkimer), 2.31 (Delaware), 2.44 (Ulster), 2.36 (Otsego), 2.49 (Chenango), 2.43 (Cayuga), 2.46 (Schoharie), 2.54 (Cortland), 2.35 (Tompkins) and 2.63 (New York) respectively.
